# **Financial Report**

Maguire gave an update on the financial status of Taste N Glow. Money Market account has an ending balance of \$77,367.56 with the checking account ending balance of \$3,039.81. Maguire moved onto the Statement of Activity report and stated year to date interest is \$668.80 in all accounts.

## **Volunteer Update**

Maguire stated she has been looking into a volunteer platform that can help streamline the signup of volunteers, organize charities, compile post event reports, and check in & out volunteers on field grounds. Maguire stated platform as the capability to send out direct emails and SMS (text) messages for reminders and updates. The cost of the platform is \$600.00 for one-time event.

Discussion by community members and board members on the purchase of volunteer t-shirts for 2024. Discussion about using lanyards with volunteer card instead was made. Maguire stated she will research

out lanyard options for the upcoming meeting discussion.

A call for a motion to purchase the Volunteer app made by C. Jilek, second by Thurs, approved by all.

#### **Presale of Tickets:**

B. Jilek stated he did research on offering presale tickets that can be linked to the website. Zeffy Platform was shown on the TV for everyone to view. Board agreed it would streamline the admission process and can generate income before the event.

A call for a motion to move forward with pre-sale of tickets using the Zeffy platform made by C. Jilek, second by Thurs, approved by all.

# **Balloon Meister Update**

Maguire gave a brief update that she has been in contact with Vicki, the Taste N Glow's Balloon Meister. Maguire brought the contract Vicki send and Brandon Jilek overlooked it and signed. Maguire stated Vicki is reaching out to her contacts to see if they can attend the event. Once we have a signed contract, Vicki will take the lead to make sure current pilots have all their paperwork in order.

#### **Parking Area Update**

R. Sliwicki gave an update that he has been working with Vreeland Land Surveyors and they are willing to map out the parking land so event would have parking spaces and lanes/avenues to be more organized.
