

Rules and Regulations

1. Setup and Teardown:

Vendor assumes responsibility and liability for all setup and teardown costs associated with being a vendor including, but not limited to: setup of booth, including tables, chairs, curtains, tents, shelves, or any other items specific to Vendor's needs; operation of booth; moving all Vendor-owned vehicles and equipment; etc.

2. Hours of Operation:

The set-up date is July 9, 2026, and the final set-up is to be done by July 9th at 10:00 p.m. All vendors must be set up and spaces must be occupied no later than 11:00 a.m. each day of ("T&G"). Nightly shutdown will be when the festival closes for the evening unless otherwise stated by ("T&G"). Release time on Sunday, July 12, 2026, **not before** unless otherwise stated by the Food Vendor Coordinator.

3. Parking:

Behind stand or in general parking

4. Non-Exclusive:

Vendor recognizes and agrees that ("T&G") does not guarantee exclusivity, i.e., there may be other vendors at the festival who are selling similar products. ("T&G") will make a reasonable effort not to put vendors selling similar items and/or services in close proximity to one another but cannot guarantee placement.

5. Acceptance:

Completing this application does not guarantee acceptance.

6. General Liability Insurance:

All vendors must have occurrence from commercial general liability insurance coverage on their activities and operations at the festival. A **Certificate of Insurance should be provided with this application**. Coverage requirements are as follows:

1) Minimum of \$300,000

2) Trailmates Snowmobile Club & Taste 'N Glow Balloon Festival must be named as "additional insured" with respect to Vendor operations/activities to ins insurance certificate.

7. Wisconsin Sales & Use Tax Exemption Certificate:

All vendors need to fill out and submit the Wisconsin Temporary Event Report Form S-240 in order to be considered as a potential food vendor.
